#### O R D E R

The petitioner was initially appointed as School Assistant and ultimately he was appointed as Associate Professor in Chemistry in Kanchi Mammunivar Center for Postgraduate Studies run by the Government. The petitioner on attaining the age of superannuation retired on 25.07.2014. It is the grievance of the petitioner that the third respondent failed to pay him certain benefits, which is due to him. The petitioner submitted a comprehensive representation on 3.11.2011 even before his retirement requesting the third respondent to look into his grievance and pass appropriate orders. However, there was no follow up action taken by the third respondent, resulting in filing this Writ Petition.

2. Heard the petitioner, who appeared as party in person and the learned Additional Government Pleader appearing on behalf of respondents 1 to 4.

3. The third respondent is directed to consider and dispose of the representation submitted by the petitioner dated 3.11.2011 on merits and as per law. In case the third respondent requires any further particulars, they should call upon the petitioner to produce those particulars, giving him two weeks time. The representation should be decided by the third respondent, as expeditiously as possible and in any case, within a period of two months from the date of receipt of a copy of this order.

4. The Writ Petition is disposed of with the above direction. No costs. The connected Miscellaneous Petition is closed.

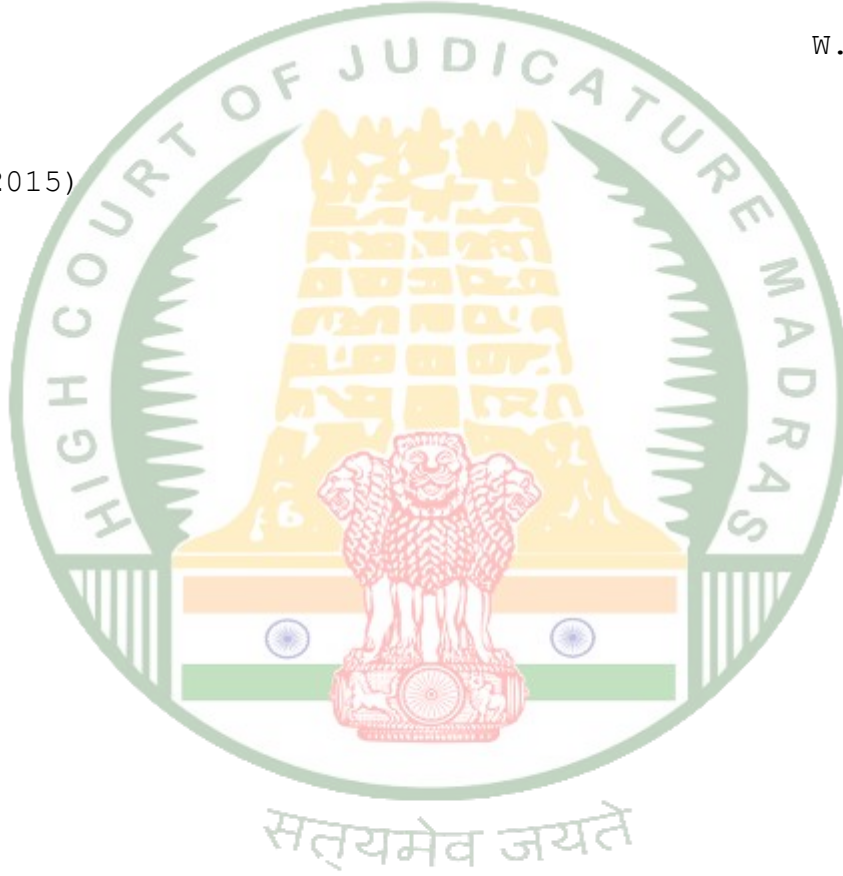
