PRAYER : This Writ Petition is filed under Article 226 of the Constitution of India for issuance of a Writ of Mandamus, directing the first respondent to grant prospecting licence for two years and quarrying lease for 20 years in favour of the petitioner in respect of Government quarry lands measuring 17.00.0 hectares comprised in S.F. No.609/A of 162 Nagojanahalli, Pochampalli, Krishnagiri and shown in the sketch annexed with application by considering the petitioner's quarrying lease application dated 04.10.2014 under the Granite Conservation and Development Rules 1999 and pass such further orders.

ORDER
