Hence, this Writ Petition is disposed of by directing the learned District Munsif, Sholinghur to dispose of the I.A.No.515 of 2012, within a period of eight weeks from the date of receipt of a copy of this order. While doing so, the said Court has to look into the communication dated 01.10.2013 sent by the Ayyarpadi Panchayat to the petitioner. The petitioner is at liberty to file the said proceeding before the Civil Court. No costs. Consequently, connected Miscellaneous Petition is closed.
