W.P.No.22828 of 2012 filed under Article 226 of the Constitution of India to issue a Writ of Certiorari, to call for the records of the respondent in tender notification in Na.Ka.No.24/2012/A2 dated 08.08.2012 and quash the same, insofar as the work mentioned in S.No.4 and 7 is concerned, as being illegal and against the provisions of G.O.Ms.No.92 (Municipal Administration and Water Supply) dated 03.07.2007.

W.P.No.22829 of 2012 filed under Article 226 of the Constitution of India to issue a Writ of Certiorarified Mandamus to call for the records of the respondent in Na.Ka.No.292/2012/A5 dated 30.07.2012 and to quash the same, and for a consequential direction to the respondent to renew the lease/licence granted to the petitioner in respect of collection of toll fee in collecting the toll fee in respect of loading and off-loading of vehicles and in respect of collection of toll fee from shops in the market for a further period from September 2012, in accordance with the provisions of G.O.Ms.No.92 (Municipal Administration and Water Supply) dated 03.07.2007.
