This ompany Petition coming on this day before this court for hearing, the Court made the following order:-

By order dated 02.12.2013, this Court, while admitting the Company Petition for winding up, ordered notice as contemplated under the Act. Apart from other things, this Court also directed the petitioner to publish the Company Petition in Tamil Nadu Government Gazette fixing the date of hearing on 10.01.2014.

2. When the matter was taken up for hearing today, the learned counsel for the petitioner submitted that by inadvertance, the petitioner failed to publish in the Tamil Nadu Government Gazette as directed by this Court. In these circumstances, the learned counsel appearing for the petitioner submitted that the petitioner is prepared to redo the exercise.

3. Having regard to the submission made by the learned counsel for the petitioner, the following order is passed:

(i) Notice on the Court Notice Board.

(ii) Notice to the respondent.

(iii) Notice to the Registrar of Companies, Chennai.

(iv) Affixure of notice at the premises of the Registered Office of the respondent-Company.

(v) The petitioner is directed to publish the Company Petition in one issue of Tamil daily "Malai Murasu" and in one issue of English daily "The New Indian Express" and also in the Tamil Nadu Government Gazette fixing the date of hearing on 10.10.2014.
