The two-fold grievances which the petitioner makes qua respondent no.5 is that the said respondent is obstructing public street and a common well has been blocked.

2.The records show that the well in question was a dried well.

3.In so far as the issue of encroachment on public street is concerned, let the third respondent / Tahsildar look into this aspect and take a decision within two (2) months of the receipt of this order, after notice to all concerned, by a speaking order.

4.Writ Petition, accordingly, stands disposed of. No costs. Consequently, M.P.No.1 of 2009 stands closed.

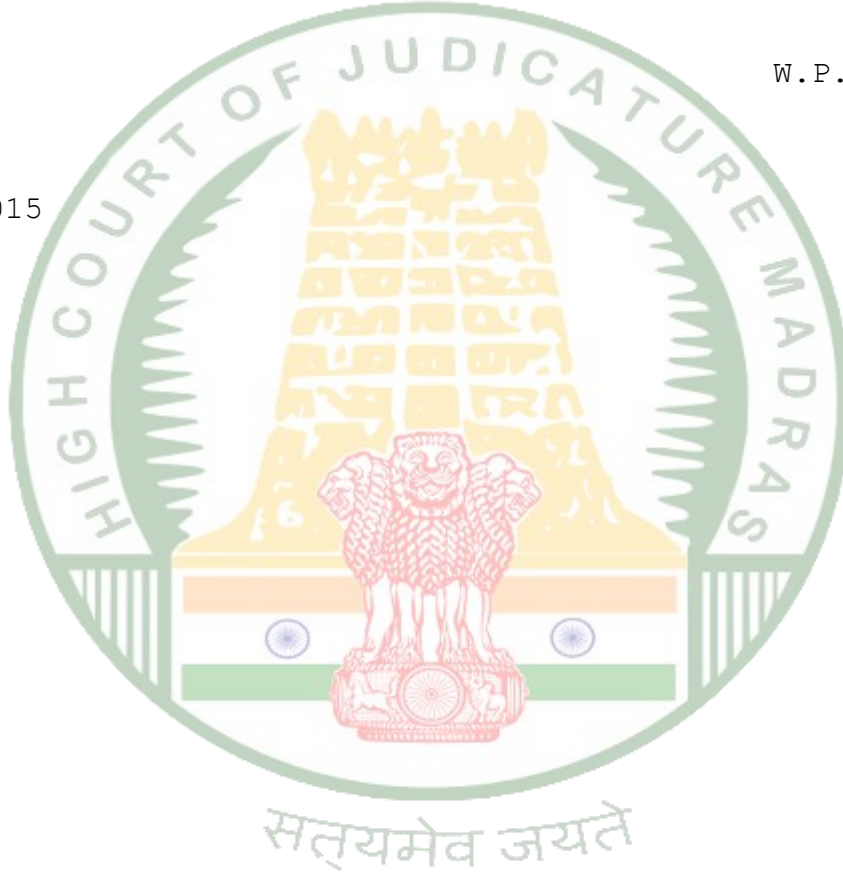
