Writ petition is filed under 226 of the Constitution of India calling for the records of the fourth and fifth respondents in relation to the proceedings issued in Na.Ka.AA/1142/2002 dated 25.04.2003 in Na.Ka.No.AA/1142/2002 dated 15.10.2003 and in AG (A & E)/Pension PO9/2/V132-1832/RTD/2006-2007/13468 dated 20.02.2007 respectively and quash the same and issue a consequential direction to the respondents to restore the pay of the petitioner at Rs.1760/- in the scale of pay of Rs.1640-2900 with effect from 01.06.1988 and fix the petitioner's pay at Rs.10475/- as on 31.07.2002 and then fix pension and release the amount of Rs.1,66,238/- recovered from the amount of gratuity to the petitioner with interest @ 18% per annum.
