Writ Petition filed under Article 226 of the Constitution of India for the relief of issuance of Writ of Mandamus, directing the 2nd respondent to assess the petitioner's Bill of Entry No.12412, dated 05.06.2002 pertaining to import of 3432 pieces of Portable Emergency Lamps, Model No.PRL-786 to the usual Customs and Counter Vailing Duty on the value on the value at US\$ 3.25 per unit and 16% on the Maximum Retain Price Rs.330 plus SAD 4% on the assessed value and to clear the goods.
