ORDER

Mr.S.Shanmugam filed O.A.No.1490 of 2004 before the Tamil Nadu Administrative Tribunal, Chennai challenging the punishment order and the denial of promotion to the petitioner. Thereafter, the matter came on transfer and renumbered as the present writ petition.

2. When the matter was taken up, the learned counsel for the petitioner submitted that during the pendency of the matter, the petitioner was subsequently given promotion to the post of Deputy Block Development Officer and he retired from service on 31.7.2006 and that he was paid with all the terminal benefits and thereafter he also passed away on 14.11.2014. Therefore, nothing survives in the writ petition.

3. Recording the above submission, this writ petition is dismissed, as nothing survives for adjudication. No costs.
