Prayer in W.P.No.12710/2002:It may be pleased to issue a Writ of Mandamus or any other appropriate writ or order of direction in nature of a writ directing the respondents to permit the petitioner to quarry stones from the lease hold area bearing S.F.No.243/1 Part 2 admeasuring 2.00 Acre in Thondanthulasi Village, Katpadi Taluk, Vellore District for five years from the execution of the lease Deed dated 9.5.98 and pass such further and other order as this Hon'ble Court may deem fit.

Prayer in 12707/02:

It may be pleased to issue a Writ of Mandamus or any other appropriate writ or order of direction in nature of a writ directing the respondents to permit the petitioner to quarry stones from the lease hold area bearing S.F.No.1/1 Part 1 admeasuring 1.00 Acre in Alnganeri Village, Katpadi Taluk, Vellore District for five years from the execution of the lease Deed dated 3.8.98 and pass such further and other order as this Hon'ble Court may deem fit.

Prayer in 12709/02:

It may be pleased to issue a Writ of Mandamus or any other appropriate writ or order of direction in nature of a writ directing the respondents to permit the petitioner to quarry stones from the lease hold area bearing S.F.No.1/1 Part 3 admeasuring 1.00 Acre in Alnganeri Village, Katpadi Taluk, Vellore District for five years from the execution of the Lease Deed dated 20.7.98 and pass such further or other order as this Hon'ble Court may deem fit.

J U D G M E N T

(Judgment of the Court was delivered by The Hon'ble Chief Justice)

Learned Single Judge allowed the writ petitions permitting the quarrying operation for a full period of five years. That period expired long time back and not even notice has been issued in these appeals, which are pending for the last 13 years.

2.Writ Appeals are, thus, dismissed as infructuous. Consequently, connected miscellaneous petitions are also dismissed.
