PETITION FOR BAIL Under Sec. 439 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioners, who are arrayed accused Nos.1 & 2, were arrested and remanded to judicial custody on 18.05.2015 for the alleged offences punishable under Sections 8(c) r/w 20(b) (ii) (B) of NDPS Act, in Cr.No.156 of 2015 on the file of the respondent police and hence, seek bail.

2.The case of the prosecution is that the petitioners were found in possession of 1.100 kgs of Ganja.

3.The learned counsel for the petitioners submitted that both the petitioners are ladies and they have been falsely roped in this case.

4.The learned Government Advocate (Crl.side) submitted that the first petitioner is having 6 previous cases and the second petitioner is having 3 previous cases. All the cases are similar in nature.

5.Considering the nature of allegations made against the petitioners and the circumstances under which the petitioners are arrested and quantity of the Ganja, the investigation is over and the period of detention, this Court is inclined to grant bail to the petitioners with certain conditions. Accordingly, the petitioners are ordered to be released on bail on each executing a bond for a



sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Principal Special Court for EC & NDPS Act Cases, Madurai and on further condition that the petitioners shall report before the respondent police daily twice at 10.00 a.m., and 5.00 p.m., until further orders.
