4.The learned Counsel appearing for the defacto complainant submitted that he has given a complaint for forgery.

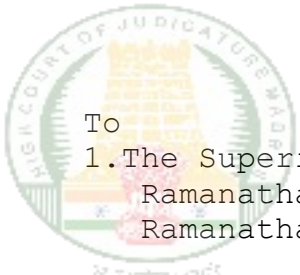
