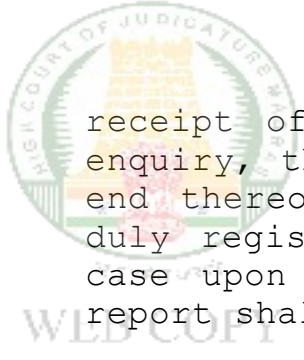
This petition has been filed under Section 482 Cr.P.C, praying to direct the respondents to register a case on the petition of the petitioner dated 25.05.2015.

2.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl.side).

3.The learned counsel for the petitioner submitted that the petitioner sent a representation to both the respondents on 25.05.2015 to take appropriate action against the proposed accused, who harassed the petitioner. Even after receiving the above said representation, no action has been taken on the complaint. Hence, the present petition has been filed.

4.The learned Government Advocate(Crl.side) on instruction would submit that petition enquiry is pending.

5. As per the judgment of the Hon'ble Supreme Court in *Lalita Kumber v. State of U.P. & others* [2013 (4) Crimes 243 (SC)], the respondents concerned may conduct a preliminary enquiry, which shall not extend beyond a period of two weeks from the date of



receipt of a copy of this order. In conducting the preliminary enquiry, they shall put the concerned parties upon notice. At the end thereof, if any cognizable offence is made out, they shall duly register a case. In the event of effecting closure of the case upon conducting a petition enquiry, a copy of the closure report shall be forwarded to the complainant.

6. The Criminal Original Petition is disposed of with the above direction.
