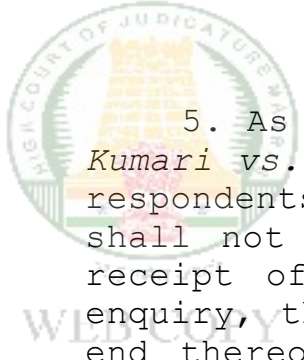
O R D E R

Government Advocate (Crl.side).

3.The learned counsel for the petitioner submitted that the
petitioner preferred a representation before the first respondent
on 11.06.2015 to direct the second respondent to take appropriate
action against the proposed accused on her complaint dated
31.01.2015, who harassed the petitioner. Even after receiving the
said complaint, no action has been taken on the complaint. Hence,
the present petition has been filed.

As per the judgment of the Hon'ble Supreme Court in *Lalita Kumari vs. Govt. of U.P. & others* [2013 (4) Crimes 243 (SC)], the respondents concerned may conduct a preliminary enquiry, which shall not extend beyond a period of two weeks from the date of receipt of a copy of this order. In conducting the preliminary enquiry, they shall put the concerned parties upon notice. At the end thereof, if any cognizable offence is made out, they shall duly register a case. In the event of effecting closure of the case upon conducting a petition enquiry, a copy of the closure report shall be forwarded to the complainant.

6. The Criminal Original Petition is disposed of with the above direction.
