Prayer in CRL OP(MD).11046/2015:

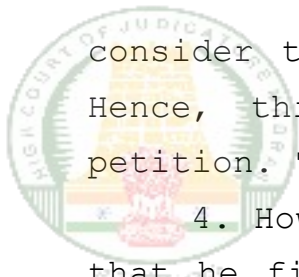
