Prayer in CRL OP(MD) No.11451 of 2015:

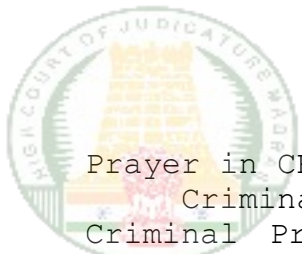
