**Prayer in CRL OP(MD) No.12124 of 2015:**

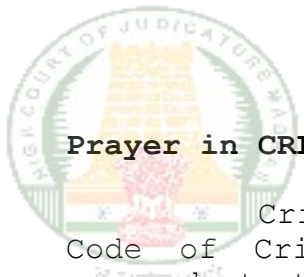
