3.According to the petitioner, two complaints have been given on 20.12.2014 and 30.06.2015 respectively.

4.The learned Government Advocate (Crl.Side) would submit that there is no complaint received by the respondents.

5.It appears that earlier both the petitioner and the proposed accused gave complaint each other. It also appears that the proposed accused has agreed to pay some amount to the petitioner, which said to have been borrowed from him. On his failure to repay it, subsequent complaint has been given.
