PETITION FOR BAIL Under Sec. 439 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who is arrayed as accused No.3 in Crime No.96 of 2015 on the file of the respondent police, was arrested for the alleged offences punishable under Sections 147, 148, 294(b), 323, 324, 307 and 506(ii) of I.P.C., and hence, seeks bail.

2. The learned counsel for the petitioner submitted that the petitioner is innocent and he has been falsely implicated in this case.

3. The learned Government Advocate (Crl.side) submitted that this is a case of case and counter and the injured has been discharged from the hospital.

4. Considering the submissions made by the learned Government Advocate (Crl.side), this Court is inclined to grant bail to the petitioner with certain conditions. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) each with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate, Cheranmahadevi, Tirunelveli District and on further condition that the petitioner shall appear before the respondent police daily at 10.00 a.m. until further orders.
