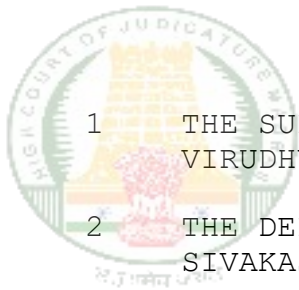

Prayer in CRL OP(MD) No.12203 of 2015:

To direct the respondent to register the complaint of the petitioner dated 12.4.2015 and investigate the same in accordance with law.

Prayer in CRL OP(MD) No.12223 of 2015:

To direct the respondent to register the petitioners complaint dated 27/01/2014 as an F.I.R. and further direct him to investigate into the matter and to file the final report within the stipulated period as prescribed by this Hon'ble Court.

Prayer in CRL OP(MD) No.12224 of 2015:

To direct the inspector of police East Police Station, Sivakasi, to register the complaint dated 17/06/2015 given by the petitioner herein and thus render justice.

Prayer in CRL OP(MD) No.12259 of 2015:

To direct the 2nd respondent to register First Information Report against the accused on the basis of the petitioner complaint dated 07/06/2015 and investigate the matter in accordance with law and pass such orders as this Hon'ble Court.

Prayer in CRL OP(MD) No.12260 of 2015:

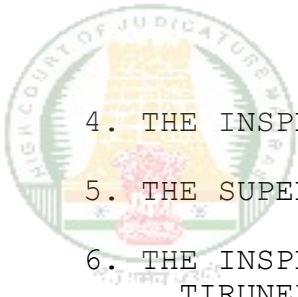
