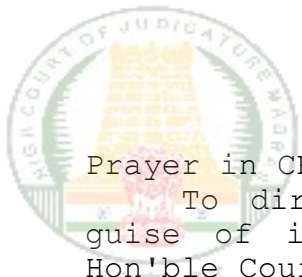

To direct the 2nd respondent that not to harass the petitioner in the guise of enquiry based on the complaint given by one Chitra and pass such further or other orders as this Hon'ble Court.

Prayer in CRL OP(MD) No.13017 of 2015:

To direct the 1st and 2nd respondents and their men not to harass the petitioners based on the complaints of the 3rd respondent.

Prayer in CRL OP(MD) No.13155 of 2015:

To issue a direction to the respondents not to interfere in the civil dispute between the parties concerned in C.R.P.(NPD)No. 2003/2011 pending before this Hon'ble Court, in respect of the land property in survey Nos. 335/4, 335/7, 332/2 and 332/3 at the extent of 2 acres and 56 cents situate at Matharai, Nakkalappatti village, Usilampatti Taluk, Madurai District.
