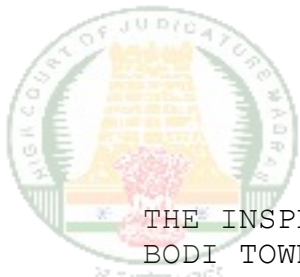

To grant direction, directing the 2nd respondent to take the complaint dated 27.06.2015 made by the petitioner into investigation and register the same in accordance with law and file final report before the concerned Judicial magistrate court, within the time limit that may be stipulated by this Honble Court.
