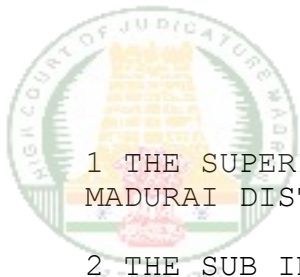

These Criminal Original Petitions have been filed for a direction to the concerned respondents to register the case based on the petitioner's/ petitioners' complaint.

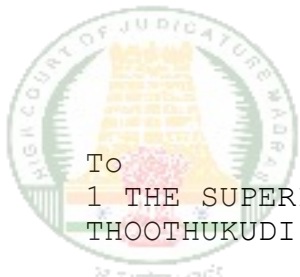
2. The learned Government Advocate (Crl. Side) on instructions, would submit that in all these cases no complaint has been received by the respondent police.

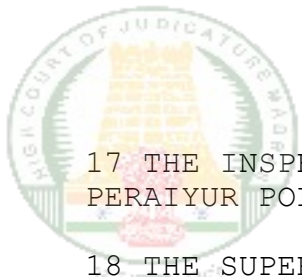
