ORDER

This Criminal Original Petition has been filed to quash the F.I.R in Cr.No.350 of 2015 pending on the file of the first respondent.

2. The petitioner has been arrayed as accused in Crime No.350 of 2015 on the file of the first respondent.

3. When the matter is taken up for hearing, the parties namely, the petitioner and the defacto complainant are present before this Court. Both parties submitted that the matter has been settled. A joint compromise memo has been filed, which contains the signature of the petitioner and the second respondent. The same was attested by the learned counsel on both sides.

4.Heard both sides and also perused the compromise memo. The appearance of the parties is recorded.

5.Considering the submissions made and after going through the relevant documents and after looking at the nature of offences alleged against the petitioner, this Court is inclined to quash the proceedings pending against the petitioner.
