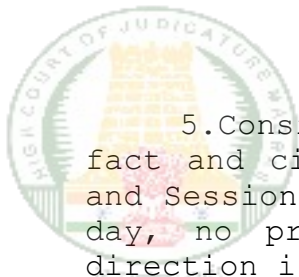
#### ORDER

The petitioners approach this Court to direct the Principal District and Sessions Court, Theni to consider the petitioners bail application on the same day of their surrender in respect of Spl.S.C.No.12 of 2013 on the file of the Principal District and Sessions Court, Theni on the very same day.

2. The petitioners are alleged to have committed an offence under Sections 147, 294(b), 355 and 323 of I.P.C., and 3(1)(X) of SC/ST Act. It is stated by the petitioners that they are innocent.

3. The learned counsel for the petitioners would submit that the petitioners are prepared to surrender before the lower Court to co-operate with the prosecution and their petitions for bail may be ordered to be considered on the same day.

4. The learned Government Advocate (Crl. Side) would oppose the said request.

5.Considering the submission of the petitioners and considering the fact and circumstances by issuing a direction to the Principal District and Sessions Court, Theni to dispose of the petition for bail on the same day, no prejudice would be caused to the prosecution, the following direction is issued to the lower Court:-

WEB COPY "In the event of the petitioners surrendering before the Principal District and Sessions Court, Theni and their filing of petition seeking bail, the Principal District and Sessions Court, Theni shall dispose of the said petition for bail on the same day strictly on merits and in accordance with law."

6.Accordingly, the Criminal Original Petition stands disposed of.
