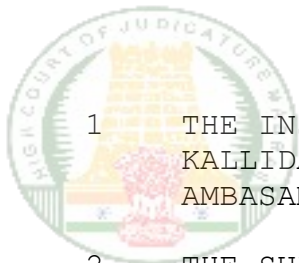

To pass an order an order directing the respondents to register a case on the complaint of the petitioner dated 25/04/2015 and pass such further or other order as this Hon'ble Court.

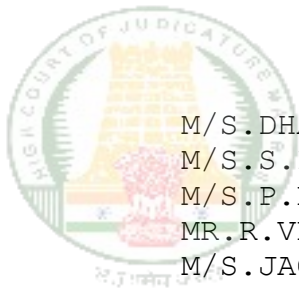

4. With the above direction, these Criminal Original Petitions are disposed of.

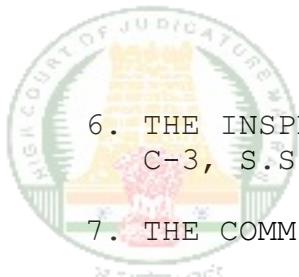
