PETITION FOR BAIL Under Sec. 439 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who is arrayed as accused in Crime No.276 of 2015 on the file of the respondent police, was arrested and remanded to judicial custody on 03.07.2015 for the alleged offences punishable under Sections 3, 4 and 5 of I.T.P Act 1956 and hence, seeks bail.

2.The allegation against the petitioner is that he assaulted sexually exploiting one Priya on 01.07.2015 for monetary gain.

3.The learned counsel for the petitioner submitted that the petitioner is an innocent person and he has been falsely implicated in this case.

4.The learned Government Advocate (Crl.side)would submit that the petitioner belongs to the State of Kerala and he has no bad antecedent.

5.Considering the facts and circumstances of the case, this Court is inclined to enlarge the petitioner on bail on the following conditions.

6.Accordingly, the petitioner is directed to be released on bail on executing a bond for a sum of Rs.10,000/-(Rupees ten thousand only) with two local sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.V, Trichy and on further condition that the petitioner shall report before the respondent police daily at 10.00 a.m., for a period of two weeks and thereafter as and when required for interrogation.
