2.Heard the learned counsel for the petitioners and the learned Government Advocate (Crl.side).

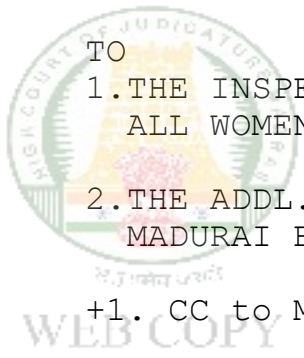
