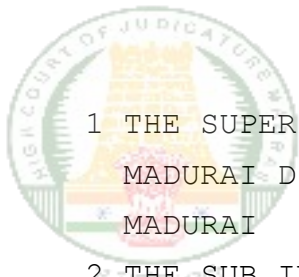

Prayer in CRL OP(MD). 14892/ 2015 : To register a case on the complaint dated 24.07.2015 lodged by the petitioner and pass such further or other orders, as this Honble Court may deem fit and proper in the circumstances of the case and thus render justice.

Prayer in CRL OP(MD). 14910/ 2015 : To direct the 2nd respondent to register the complaint dated 15.02.2015 preferred by the petitioner for the offences punishable under section 420, 465, 467, 468 and 470 IPC and to take action against the accused person in accordance with law.

4. With the above directions, these Criminal Original Petitions are disposed of.

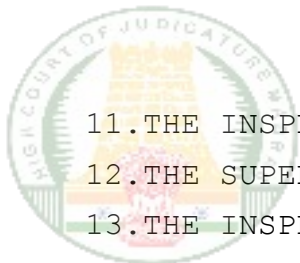
