#### O R D E R

The petitioner has come forward with this petition seeking for a direction, directing the second respondent to register a case on the basis of the complaint dated 08.08.2015 given by the petitioner and file a final report within time stipulated by this Court.

The learned counsel for the petitioner submitted that the petitioner has given a complaint to the second respondent as early as on 08.08.2015, but, however, the second respondent police had not taken any steps to register a case and hence, the petitioner has come forward with this petition for the above stated relief.

3. At this juncture, the learned Government Advocate(Crl. Side), on instructions, would submit that based on the complaint given by the petitioner an enquiry has been conducted and the statement was also recorded regarding the compromise.

4. Considering the rival submission made on both sides, the second respondent is directed to expedite the enquiry and follow the dictum laid down in *Lalitha Kumari vs. Govt. of U.P & others* [2013 (4) Crimes 243 (SC)] and register a case, if any cognizable offence is made out.



5. The Criminal Original Petition is disposed of with the above direction.
