The petitioner has come forward with this petition seeking for a direction, directing the respondent No.2 to register FIR on the basis of the petitioner's complaint dated 27.06.2014 and to initiate necessary action in accordance with law within the time stipulated by this Court.

The learned counsel for the petitioner submitted that the petitioner has given a complaint to the second respondent as early as on 27.06.2014, but, however, the second respondent police had not taken any steps to register a case and hence, the petitioner has come forward with this petition for the above stated relief.

4. Considering the rival submission made on both sides, the second respondent is directed to expedite the enquiry and follow the dictum laid down in **Lalitha Kumari vs. Govt. of U.P & others [2013 (4) Crimes 243 (SC)]** and register a case, if any cognizable offence is made out.

5. The Criminal Original Petition is disposed of with the above direction.
