ORDER

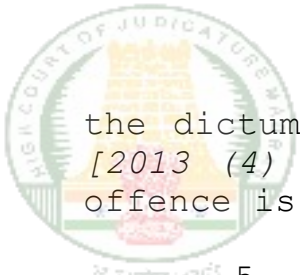
The petitioner has come forward with this petition seeking for a direction, directing the respondents to register the case based on the petitioner's complaint dated 13.08.2015.
