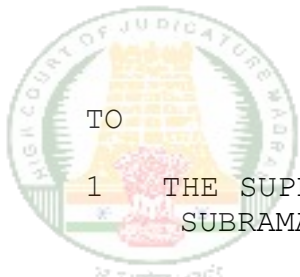
5. The Criminal Original Petition is disposed of with the above direction.
