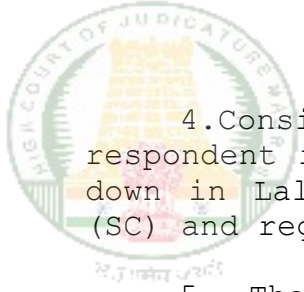

07.09.2015, but, however, the second respondent police had not taken any
steps to register a case and hence, the petitioner has come forward with
this petition for the above stated relief.

instructions, would submit that based on the complaint given by the
petitioner in Current Paper No.G3/260/22/1905/2015, petition enquiry is
going on.



4.Considering the rival submission made on both sides, the second respondent is directed to expedite the enquiry and follow the dictum laid down in Lalitha Kumari vs. Govt. of U.P & others [2013 (4) Crimes 243 (SC) and register a case, if any cognizable offence is made out.
