2.The learned counsel for the petitioners submitted that both parties have entered into compromise out of the Court and the petitioners are ready to donate Rs.15,000/- to BHARATHAN MUTHUKUMARASAMY PANCHAYAT PRIMARY SCHOOL, T.KALLUPATTI in favour of GOPALAKRISHNAN.R. SB.NO.1016101072796 IFSC Code:CNRB0001016, Canara Bank, Peraiyur, Madurai District.



3.The defacto complainant has no objection to quash the CC No.596 of 2013, on the file of the Judicial Magistrate, Theni.

4.Considering the facts and submissions of the learned counsel for the petitioners, the petitioners/A1 to A6 are permitted to pay a sum of Rs.15,000/- (Rupees Fifteen Thousand only) to the BHARATHAN MUTHUKUMARASAMY PANCHAYAT PRIMARY SCHOOL, T.KALLUPATTI in favour of GOPALAKRISHNAN.R SB.NO.1016101072796 IFSC Code: CNRB0001016, Canara Bank, Peraiyur, Madurai District.

5.Post this matter on 30.11.2016. The appearance of the parties is dispensed with.
