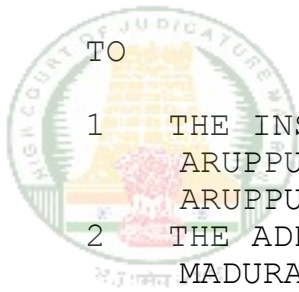
4. Recording the submission made by the learned Government Advocate (Crl.Side), this criminal original petition is dismissed.
