4. Considering the rival submission made on both sides, the second respondent is directed to expedite the enquiry and follow the dictum laid down in **Salisha Kumari vs. Govt. of U.P & others [2013 (4) Crimes 243 (SC)]** and register a case, if any cognizable offence is made out.



5. The Criminal Original Petition is disposed of with the above direction.
