ORDER

This petition has been filed under Section 482 Cr.P.C., praying to direct the respondents 1 to 3 not to interfere into the pending civil disputes between the petitioner and the respondents 4 and 5 in respect of the landed property comprising in Vilpatty Village in Survey Nos.78, 79, 80, 81, 82, 83 and 87 of Kodaikanal Taluk, Dindigul District and not to alter the physical features by putting fence.

2.Learned counsel for the petitioner submits that the respondents are interfering towards depriving the petitioner of property while cases there regards are pending before the civil Court. In the said circumstances, the petitioner is repeatedly called by the respondent police.
