PRAYER: Criminal Original Petition is filed under Section 482 Cr.P.C., to direct the learned District Judge, Virudhunagar at Srivilliputhur to pass order on the bail petition filed by the petitioner on the same day of surrender in Crime No. 162 of 2015 on the file of the Deputy Superintendent of Police, Malli Police Station, Srivilliputhur, Virudhunagar District or pass any other order as this Court deems fit for this case.

ORDER

The petitioners, who apprehend arrest for the offences punishable under Sections 147, 341, 294(b), 323, 506(i) IPC., and Sections 3(1)(r) (s) 3(2)(va) of SC/ST Prevention of Atrocities Act (Amendment Ordinance 2014), in Crime No.162 of 2015, on the file of the respondent police, moved this petition seeking a direction to the learned District Judge, Virudhunagar at Srivilliputhur to accept the surrender of the petitioners and consider the bail application on the same day on merits.

2. I have heard the learned counsel appearing on either side and perused the records.

3. The learned Government Advocate (Criminal side) strongly opposed the relief sought for by the petitioners. He would submit that injured had already been discharged from the hospital and co-accused were already arrested and released on bail.

4. The offences complained of, other than the offence under the Special enactment, may not be serious in nature warranting initial detention in jail, even before considering the bail application.

5. Therefore, the learned District Judge, Virudhunagar at <https://hservices.ecourts.gov.in/hservices/> directed to accept the surrender of the petitioners and consider their bail application on the very same day, purely on merits and in accordance with law.



6. Accordingly, this Criminal Original Petition is ordered.
