ORDER

This petition has been filed seeking to quash the case in Crime No.21 of 2015, pending before the 1st respondent Police.

2. It is seen that the case in Crime No.21 of 2015 has been registered against the petitioners / Accused.

3. When the matter is taken up for hearing, the petitioners / Accused and the 2nd respondent / defacto complainant, have appeared in persons and their identifications were also verified by this Court, in addition to the confirmation of the parties by the Government Advocate (Crl.Side) through the respondent Police.

4. The counsel appearing on either side would submit that a Compromise Memo has been filed stating that, since the parties have arrived at an amicable settlement by way of compromise among themselves, the second respondent has agreed to withdraw the case in Crime No.21 of 2015.

5. Considering the nature of allegations and also considering the Compromise Memo, this Court is of the opinion that no useful purpose would be served in keeping these matters pending. Therefore, the case in Crime No.21 of 2015, pending on the file of the 1st respondent, in so far as the petitioners are concerned, is hereby quashed.
