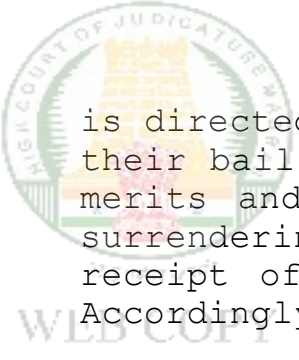

The petitioners, who apprehend arrest for the offences punishable under Sections 294(b), 323, 354, 452 IPC r/w Section 3 (1)(X) of SC & ST Amendment Ordinance Act, 2013, in Cr.No.219 of 2015, on the file of the respondent police, move this petition seeking direction to the learned III Additional District and Sessions Judge cum SC ST (Prevention of Atrocities) Act, (PCR Unit), Madurai, to consider the bail applications filed by the petitioners on the same day of their surrender.

2.The offences complained of, other than the offence under the Special enactment, even though serious since the injured has been discharged from the hospital the same can be considered by the said Court on the same day.

Accordingly, this Criminal Original Petition is ordered.
