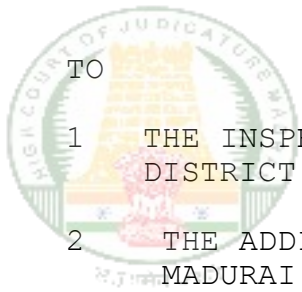
PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.
