O R D E R

This petition has been filed seeking to quash the proceedings in Crime No.102 of 2014 on the file of the 1st respondent police.

2. It is seen that the above said case has been registered for the alleged offences under Sections 341, 294(b), 323 and 392 of IPC., against the petitioners / Accused.

3. When the matter is taken up for hearing, the <https://hcservices.ecourts.gov.in/hcservices/> petitioners/Accused and the second respondent/defacto complainant, have appeared in persons and their identifications were also



verified by this Court, in addition to the confirmation of the parties by the Government Advocate (Cr1.Side) through the respondent Police.

4. The counsel appearing on either side would submit that a Compromise Memo has been filed stating that, since the parties have arrived at an amicable settlement by way of compromise among themselves, the second respondent has agreed to withdraw the above case in Crime No.102 of 2014, pending on the file of the first respondent.

5. Considering the nature of allegations and also considering the Compromise Memo, this Court is of the opinion that no useful purpose would be served in keeping these matters pending. Therefore, the entire proceedings in Crime No.102 of 2014, on the file of the first respondent, is hereby quashed.

6. Accordingly, these Criminal Original Petition is allowed on the basis of the compromise entered into between the parties. The compromise memo shall form part of this order.
