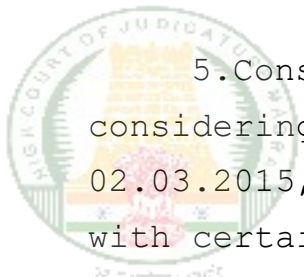
ORDER : The Court Made the following order :-

The petitioner is the sole accused and he was arrested and remanded to judicial custody on 02.03.2015 for the alleged offences punishable under Sections 8(c) r/w 20(b)(ii)(B) of NDPS Act, in Crime No.131 of 2015 on the file of the respondent police and hence, seeks bail.

2. The case of the prosecution is that the petitioner found in possession of 6 kgs ganja.

3. The learned counsel appearing for the petitioner submitted that the petitioner was arrested and remanded to the judicial custody on 02.03.2015 and after investigation, the respondent police has also laid charge sheet in this case.

4. The learned Government Advocate (Criminal side) appearing for the respondent submitted that the petitioner has involved in three other cases of similar nature and the respondent filed the charge sheet after investigation.



5.Considering the facts and circumstances of the case and also considering the fact that the petitioner is in jail since 02.03.2015, this Court is inclined to grant bail to the petitioner with certain conditions.

6.Accordingly, the petitioner is ordered to be released on bail on his executing a personal bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Additional District Judge for Principal Special Court for E.C. and NDPS Act cases, Madurai and on further condition that the petitioner shall report before the respondent police daily at 10.00 a.m. until further orders.
