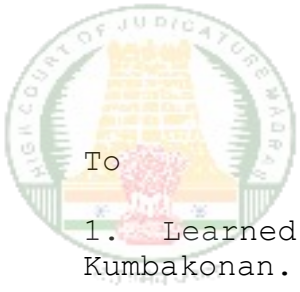
2.Heard learned counsel for the petitioners.
