PETITION FOR BAIL Under Sec. 439 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner is the sole accused and he was arrested and remanded to judicial custody on 23.03.2015 for the alleged offences punishable under Sections 8(c) r/w 20(b)(ii) of NDPS Act in Crime No.70 of 2015, on the file of the respondent police and hence, seeks bail.

2. The case of the prosecution is that the petitioner found in possession of 2 kilo 100 grams of ganja.

3. The learned counsel appearing for the petitioner submitted that the petitioner was arrested and remanded to the judicial custody on 23.03.2015.

4. Heard the learned Government Advocate (Criminal side) appearing for the respondent.

5.Considering the facts and circumstances of the case and also considering the fact that the petitioner is in jail since 23.03.2015, this Court is inclined to grant bail to the petitioner with certain conditions.

6.Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate, Pattukkottai and on further condition that the petitioner shall reside at Dindigul and report before the Dindigul Town Police Station daily at 10.00 a.m. 5.00 p.m and until further orders.
