O R D E R

The petitioner seeks a direction to the District and Sessions Judge (P.C.R. Cases), Dindigul District, to release the petitioner on bail, on the same day in the event of his surrender and filing bail application in Cr.No.113 of 2015 pending investigation on the file of the second respondent police.

2.The petitioner is accused of offences punishable under Sections 147,148,324,506(ii) of IPC r/w section 3(1)(x) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities)Amendment Ordinance Act,2014.

3.The submissions made by Mr.P.R.Prithviraj, learned counsel for the petitioner and by Mr.K.Anbarasan, learned Government Advocate (Crl. Side) representing the respondents were heard. The materials available on record were also perused.

4.Considering the nature of offences alleged against the petitioner, the fact that anticipatory bail cannot be granted in respect of offences punishable under the the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities)Amendment Ordinance Act, 2014, and that application could cause him irreparable hardship, this Court considers it appropriate to direct District and Sessions Judge (P.C.R. Cases),



Dindigul District, to consider the bail application of the petitioner on merits and pass appropriate order on the same day of his surrender.

5.The petition is ordered accordingly.
