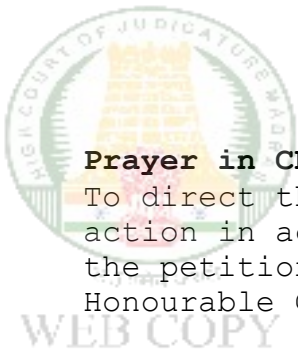

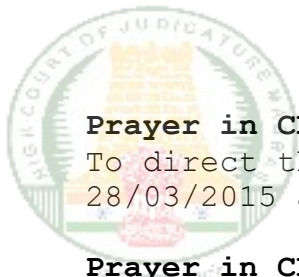

4. These Criminal Original Petitions are disposed of with the above direction.

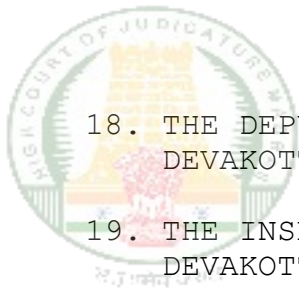
