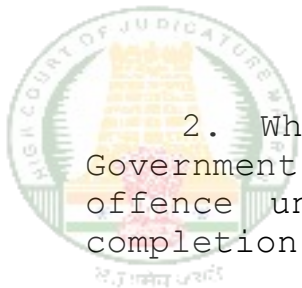

2. When the matter is taken up for hearing, the learned Government Advocate (Crl.side) on instruction submitted that the offence under Section 376 IPC is likely to be included after completion of investigation.

3. The learned counsel for the petitioner submitted that offence under Section Tamil Nadu Prohibition of Harassment of Women Act has not been included. At the time of filing final report, if the said offence is made out, the fourth respondent is directed to consider the above said issue.
