Prayer in CRL OP(MD) No.8034 of 2015:

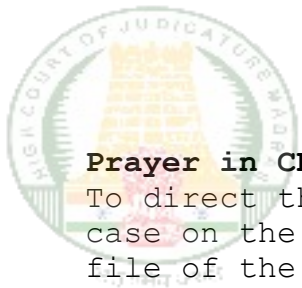
To direct the respondents to register FIR on the basis of the petitioners complaint dated 21.9.2014 within a time frame fixed orders as this Honorable Court.

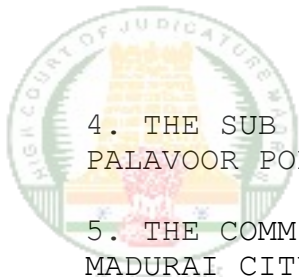
